### PROGRAM: Greg Hanscom - High Country News

Sarah introduced Greg Hanscom, Executive Director and Publisher of High Country News.

Many club members remembered Greg from his time of internship at High Country News (HCN) many years ago. He became Executive Director and Publisher of the paper in March of 2020, just as the pandemic began. He has been directing operations from his Seattle home since then.

Greg gave a brief history of HCN. The paper has been based in Paonia since 1983, when Ed and Betsy Marston moved the paper from Landers, WY to our town. At the time, the paper had \$12,000 in its bank account (currently HCN's budget is \$4.4 million a year). Ed and Betsy ran the paper for 20 years.

HCN covers a million square miles and half of that is in Public Lands. Its editorial staff is scattered all over the West with 35 employees; 2/3 of those employees work remotely. It was emphasized that HCN exists to cover more remote regions that aren't covered by the bigger city papers. HCN has a current circulation of 35,000 papers monthly, 28,000 of those are in print and the remainder online subscriptions. Its mission is to inform and inspire people to act. Greg emphasized that readers are the beating heart of the non-profit organization and that its operating budget relies on its readers' subscriptions and generous donations.
