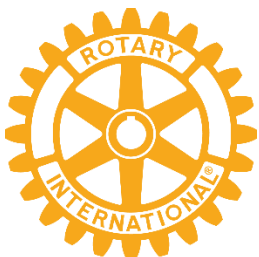
#### **PROGRAM: Courtney Rodwell: Region 10 Enterprise Zone Program**
